National Veterinary Care confirms successful acquisition

National Veterinary Care Limited (ASX:NVL) is pleased to announce the successful completion of the final three clinics which were to be settled in New Zealand as part of the announcement made on 26 August 2016. This brings the total number of clinics settled in New Zealand to seven.

These clinics are well-established businesses that have been trading in Christchurch for more than 10 years. The clinics offer a high level of professionalism and remarkable standards of care.

Total consideration for the acquisition equals NZ\$4.27M, including NZ\$0.42M in NVL shares, were issued on 3 October 2016 and held in voluntary escrow for 24 months from the date of settlement, and NZ\$0.42m in deferred cash consideration payable 24 months from the date of settlement. Both the share and deferred cash consideration are subject to a clawback provisions related to maintaining the EBIT of the business. The remainder of the consideration will be funded through free cash and debt.

The acquisition is expected to be earnings per share accretive in the 2017 fiscal year.

The NVL shares will be issued at the price of AU\$1.791 which has been calculated based on the volume weighted average price of the NVL Shares sold on the ASX for the fifteen consecutive trading days immediately prior to 3 October 2016. Please find following the Appendix 3B relating to the issue of the shares forming part of the consideration for this acquisition.
